Busy Bees Early Learning Australia will ensure that every reasonable precaution is taken to protect children from harm and any hazard likely to cause injury, especially when children are around water or involved in water-based activities.

#### **PURPOSE**

This policy aims to ensure the safety and supervision of children in and around water. This includes water play, excursions near water, hot water, drinking water and hygiene practices with water in the Service environment.

#### **SCOPE**

Children, Busy Bees Employees, Management, Visitors and Families

### **POLICY**

Drowning is the leading cause of death for children aged 1-4 years in Australia. While most drowning occurs in backyard swimming pools, it is important to be aware that children can drown in as little as 5cm of water. Therefore, Busy Bees employees will ensure health and safety practices are implemented and incorporate approaches to safe storage of water and water play experiences.

Children will always be closely supervised during water-based activities and will never to be left alone where water is present. Risk assessments will be developed that identify management strategies of water at the Service to ensure that children can experience the natural environment and engage in water play safely. This will include adding a water lanyard to the outdoor supervision plan.

# **Water Safety Policy.**



Water safety messages will be embedded in educational programs and children will be provided opportunities to experiment with water through a variety of water-based activities, which will be appropriate to weather conditions. Any equipment used i.e., wading pools, troughs, tubs, or buckets will be emptied immediately after use and stored in a way that prevents the collection of water, or where required, covered, and made inaccessible to children.

Employees will encourage children to use water effectively, discuss the differences between tap and tank water and ensure water is being saved and reused where appropriate.

Regular safety checks will be conducted to ensure any hazards are known and minimised. Any hazard detected will be documented and action will be taken immediately to correct the concern. This will also include the position of water activities to prevent slips and falls, i.e., position active **not** on a slippery surface such as concrete.

In order to minimise harm from hot water, any warm water around children will be tested to ensure that it is not too hot to cause scalding, hot drinks are not permitted in any care environment, and hot water systems storage should be set at 60°C to prevent the formation of Legionella bacteria and a temperature control device is fitted to lower the temperature of the water coming out of the taps to no higher than 45°C where possible.

Water for pets at the Service will be changed daily and only accessible to children when educators are present.

## **Water Safety Outside the Service Premises**

Busy Bees Early Learning Services do not provide excursions that involve children swimming as we are unable to provide sufficient educators that have recognised experience in water safety and rescue procedures. However, from time to time, there may be an excursion planned where there could be a body of water e.g., lake, pond, or creek. The following will be considered when planning for excursions that are near bodies of water:

- The planning of such excursions will be conducted in conjunction with Busy Bees Early Learning's
  Excursion Policy, including risk assessments and adult to child ratios for adequate supervision,
  which should be higher for experiences/excursions planned near bodies of water.
- Water safety messages are built into the children's education programs
- Supervision near bodies of water on excursions is maintained by educators who hold a first aid certificate which includes CPR

Excursion Authorisations will clearly state if bodies of water will be present and will include added safety precautions to ensure families are informed about the risk assessment procedures and about community messages regarding water safety for families to share with their children prior to the excursion.

Cardiopulmonary resuscitation (CPR) guidelines will be displayed near any water.

Adequate supervision affects all areas of Quality Education and Care and should be always considered as high priority.
